**1. USCIS Unveils National Campaign to Combat Immigration Scams**—USCIS has launched a multi-agency, national initiative to combat immigration scams to protect vulnerable immigrants from exploitation.



- USCIS has produced a new brochure, poster, public service announcements, billboard and transit ads, and a new [Web resource center](#) to raise awareness about the signs of fraud, how to avoid it, where to report it, and where to get reputable legal assistance. Printed materials are available in English and Spanish and 12 more languages are available on the USCIS [website](#). **2. USCIS Launches Citizenship Awareness Initiative**—USCIS has begun a national education campaign to raise awareness about the rights, responsibilities and importance of U.S. citizenship. The [Citizenship Public Education and Awareness Initiative](#) includes digital media, a video PSA, and print and radio messages in several languages to

direct people to citizenship preparation materials and other resources on the USCIS Citizenship Resource Center at [www.uscis.gov/citizenship](http://www.uscis.gov/citizenship). **3. USCIS Launches a Revised Civics and Citizenship Toolkit**—USCIS has published a revised Civics and Citizenship Toolkit, which includes a welcome guide for new immigrants, videos, civics flash cards to study for the citizenship test, and other educational products. **4. USCIS Proposes Enhancements to EB-5 Program**—USCIS has proposed significant enhancements to the Immigrant Investor Program, commonly referred to as the EB-5 Program, by transforming the intake and review process for immigrant investors. For more information, click [here](#).

**5. USCIS and Mississippi Implement New E-Verify Tool**—USCIS has launched Records and Information from DMVs for E-Verify (RIDE), a new feature that allows E-Verify to validate the authenticity of Mississippi driver's licenses when presented by employees for completion of Form I-9. More than 80 percent of employees present driver's licenses to establish their identities when completing the I-9. By enabling E-Verify to compare driver's license data against state records, RIDE will improve E-Verify's accuracy and combat document fraud. Previously, if an employee presented a driver's license to establish his/her identity and a social security card to establish work authorization, E-Verify could only confirm the validity of the social security card. RIDE enables E-Verify employers in Mississippi to confirm the validity of both documents. Mississippi is the first state to partner with USCIS to implement RIDE.



**6. USCIS Centralizes Filing of Form I-130 for Petitioners Outside the U.S.**—Beginning August 15, 2011, petitioners who live in countries without USCIS offices may file a Petition for Alien Relative (Form I-130) with the USCIS Chicago Lockbox. Prior regulations required overseas petitioners to file with USCIS or the U.S. State Department at the local U.S. Embassy or Consulate. Under a new regulation, petitioners who live in countries without USCIS offices may file an I-130 petition at one of these addresses:

Petitioners who live in a country with a USCIS office have the option of sending their I-130 forms to the Chicago Lockbox, or to the international USCIS office having jurisdiction over the area where they live. For more details, click [here](#).

**8. Haiti TPS Extended 18 Months**—DHS has re-designated Haiti for Temporary Protected Status (TPS) and extended the country’s current TPS designation for 18 months, through Jan. 22, 2013. USCIS encourages Haitian nationals to read the Federal Register [notice](#) which describes how to file an initial application for TPS. People who do not have TPS or a

pending TPS application may begin filing immediately, and must file before Nov. 15, 2011. People who already have Haiti TPS must wait to file for re-registration until a Federal Register notice describing the re-registration procedure is published. For more information, click [here](#).
